An Ordinance of the City of Plainview, Texas, Adopting and Approving the Budget for the Fiscal Year Beginning October 1, 2025 and Terminating September 30, 2026, a Classification and Compensation Plan For All Employees, and Making Such Appropriations for each Department, Project and Account; Authorizing the City Manager to Make Certain Transfers of Funds; Providing a Savings Clause; Providing a Severability Clause; Finding and Determining that the Meetings at Which the Ordinance is Passed are Open to the Public as Required by Law; and Providing an Effective Date. This budget will raise more total property taxes than last year's budget by \$484,495, an increase of 7.053%, and of that amount \$72,595 is tax revenue to be raised from new property added to the tax roll this year.
