## INSTRUCTIONS FOR COMPLETING THE CITY OF PLAINVIEW HOTEL OCCUPANCY TAX REPORT

## **General Information:**

- Who must file: You must file this return if you are a sole owner, partnership, corporation, or other organization that owns, operates, manages or controls any hotel or motel in Plainview, Texas.
  - Complete and detailed records must be kept of all receipts reported and exemptions or reimbursements claimed so that returns can be verified when necessary by an auditor designated by the City of Plainview.
  - Failure to file this return and pay applicable tax may result in collection action.

When to file: • Returns must be filed on or before the 20th day of the month following the reporting period.

- Returns must be filed for every period even if you have no amount subject to tax or no tax due.
- If the due date falls on a Saturday, Sunday or holiday observed by the City of Plainview, the next business day will be the due date.

Item 6	Enter the combined total of all <u>total room receipts</u> for the reporting period. Enter "0" if no receipts were collected for the reporting period.
Item 7	Enter the combined total of all <u>taxable room receipts</u> for the reporting period. Enter "0" if no taxable receipts were collected for the reporting period.
Item 8	Enter the amount of taxes due, which is seven percent (0.07) of Item 7.
Item 9	If the report is filed and the tax paid on or before the due date, enter a discount of one percent (0.01) of Item 8. Enter "0" if no discount is taken.
Item 10	Enter the taxes due after taking any applicable discount, which is Item 8 minus Item 9.
Item 11	If the report is filed or tax paid after the due date, enter a penalty of five percent (0.05) of Item 8. (Minimum penalty of \$1.00.)
Item 12	If any tax remains unpaid for 61 days or longer after the due date, enter six percent (0.06) of Item 8 calculated on a per annum rate.
