Effective January 24, 2017 per Ordinance No. 17-3646: Carbon Monoxide Detectors will be required. Sometimes during a re-roofing project, the vents will become dislodged from the appliance causing the distribution of CARBON MONOXIDE GAS in the dwelling. FOR YOUR SAFETY, residents who occupy a structure which has been re-roofed should have all vents inspected by a professional plumber or HVAC. Also required will be a \$20,000 Surety Bond and \$300,000 Liability Insurance for Commercial roofing work and/or \$100,000 Liability Insurance for residential roofing work. Two layers of roofing material (asphalt, wood shake, slate, clay, cement or asbestos tile) are no longer allowed and existing roofing material must be removed down to the decking. Proof of Energy Code compliance is required on all commercial roofs.

Work shall not be started until the application for permit has been approved by the City of Plainview Chief Building Inspector or his designee. A roofing permit is valid for 180 days. A permit shall become invalid if the authorized work is not commenced within 180 days after issuance of the permit or if the authorized work is suspended or abandoned for a period of 180 days after the time of commencing the work. A permit will be cancelled when no inspections are requested and conducted within 180 days of the date of issuance of the date of a previous inspection. Cancelled permits cannot be refunded or reinstated.
